MINUTE of Meeting of the TWEEDDALE AREA PARTNERSHIP held in St. Ronan's Primary School Hall, Innerleithen on Tuesday, 27 August 2019 at 7.00 p.m.

#### 1. WELCOME AND INTRODUCTIONS

The Chairman welcomed everyone to the meeting of the Tweeddale Area Partnership.

#### 2. LOCALITY BID FUND 1

The Chairman welcomed Julie Smith, Cook at Clovenfords Primary School and Anne Wilson the Chair of the Parent Council. They had been successful in obtaining funding in round 1 of the Locality Bid Fund for the "Julie's Kitchen Garden" project at the school. Julie had developed the idea of getting the children involved in growing vegetables. They had started with potatoes but the project had gone from strength to strength when the funding had been received. Donations had also been received from local businesses and a Tutor from Borders College had provided advice. Community involvement was also imported and a "Friends of the Garden" had been set up. Julie and Anne answered questions and in response to a question about the future it was noted that further funding would be achieved from the sale of pickles, jams and chutneys.

#### 3. NEIGHBOURHOOD SMALL SCHEMES AND QUALITY OF LIFE PROJECTS

There had been circulated copies of a paper by the Service Director Assets and Infrastructure seeking approval for the proposals detailed in the Appendix to the report and that delegated powers be given to officers to approve future applications when a decision was required between meetings of the Area Partnership, subject to certain qualifying criteria. The Councillors present approved the list of Schemes and the proposed delegated approval process.

#### 4. FEEDBACK FROM MEETING ON 12 JUNE 2019

The Minute of the meeting of the Tweeddale Area Partnership held on 12 June 2019 had been circulated along with a summary of the discussion attached as an appendix to the Minute and the Chairman highlighted the main points which had been raised.

# 5. TWEEDDALE LOCALITY PLAN: ECONOMY SKILLS AND LEARNING Transport Networks and Connections within Tweeddale

5.1 Councillor Tatler introduced Tim Stephenson and John Dellow who were responsible for the Council's involvement in public transport across the region. Shona Smith explained that following the identification of public transport being identified as a key priority actions now needed to be agreed. Tim Stephenson gave a presentation on bus services in the Tweeddale Area. He advised that local bus services were not a statutory requirement and were currently subsidised at a cost to the Council of £1.5m per annum. £200k of savings had been made in 2018 and a further £85k in 2019 without further cuts to bus services. However, a budget saving of £165k was needed in 2020 so some innovative thinking was

required so that rather than cut services alternative models could be identified. He identified under-performing routes in the area and advised that some tough decisions would be needed. He was attending all area partnerships to talk about transport and later in the year Bus Users Scotland would be holding a large public consultation and work closely with communities to form a transport plan. He highlighted some schemes in other areas which were working well and mentioned other non-bus related options.

5.2 Tim answered questions on his presentation and concerns regarding the level of savings were expressed. Information on how services were tendered for was provided. Shona Smith outlined how the round table discussions would be conducted with a template for each table to complete. Tim and John would move round the tables and participate in the discussions. At the conclusion of the discussion Shona advised that a summary of the information gathered would be circulated with the Minute and Tim encouraged everyone to engage with Bus User Scotland.

#### 6. TWEEDDALE INTERIM COMMUNITY FUND

- 6.1 There had been circulated for information copies of the interim Community Fund overview map and the internal and external funding maps for Tweeddale. It was reported that a fast track application for the sum of £275 had been approved for Walkerburn Bowling and Petangue Club.
- 6.2 There had been circulated an application from the Tweedsmuir Community Company seeking funding of £6,750 towards the design, production and erection of a series of 5 interpretation boards at the site of the Crook Inn, Tweedsmuir and 4 heritage talks/events. This was part of a larger application to the National Lottery Heritage Fund. It was agreed to approve the application.

#### 7. FUTURE AGENDA ITEMS

The Chairman advised that he was looking for ideas on how future meetings could be improved and what agenda items people might like included. Various suggestions were discussed including an early budget briefing, the Local Development Plan and a presentation on SoSEP. Ways to publicise meetings were also discussed.

#### 8. **OPEN FORUM**

- 8.1 Laura Preston from Saving Scotland's Red Squirrels advised that Peebles was the latest target area and a public meeting would be held on 4 September in Peebles which she encouraged everyone to attend.
- 8.2 Tweedsmuir Community Council advised that they were not receiving Police reports and it was confirmed that other areas were having similar problems The Chairman advised that this was the responsibility of the Local Area Commander but he would also raise this with the Community Action Team. - 8.3 Joh Falla commented on the success of the "Tweedies" project and thanked Councillors for their assistance in allowing this to be set up. He also raised the issue of flower planting for "Bonnie Peebles" next season. Councillor Haslam advised that the Council would be planting sustainable species but Community could do something different if they wished. Councillor Anderson suggested that a funding application could be submitted.
- 8.4 Chris Lewin asked how he could be sure that the Locality Bid Fund was fair for the more rural areas. Shona Smith advised that an evaluation was being prepared for Council and she would arrange for the full results to be circulated.

## 9. **NEXT MEETING**

The next meeting of the Tweeddale Area Partnership would be held on Tuesday, 7 November 2019. The venue would be confirmed before the meeting. The Chairman thanked everyone for attending.

The meeting concluded at 8.55 p.m.






# External investment in Tweeddale, April 2016 to March 2019. Total £909,951

# REPORT TO TWEEDDALE AREA PARTNERSHIP ESHIELS TUNNEL DAYTIME LIGHTING PROVISON. Nov 2019

#### INTRODUCTION AND BACKGROUND

The Area Partnership is being asked to consider the options regarding the Eshiels Tunnel which was previously railway infrastructure and now forms part of the multi user path between Peebles and Innerleithen.

The tunnel sits close to the Eshiels Recycling Centre and is approximately 60m long and 4m wide. The height changes from 3.5m at the eastern entrance to 2.4m at the western entrance. There has previously been a site visit with officers from the Scottish Borders Council. Photos of the tunnel from both sides are attached for reference.

As the Partnership will be aware there have been incidents and accidents which have been reported as due to the unlit tunnel. Mitigating works have previously been installed including warning signs, slow signs painted on the path and path lining in white paint.

## LIGHTING DESIGN

In order to consider lighting provision during the daytime for the Eshiels Tunnel and to comply with legal requirements to protect bats a Bat Survey was carried out. This was done in association with Sustrans who funded the Bat Survey by Tweed Ecology (copy survey available on request). The Bat Survey did find evidence of bats and has summarised permissions and conditions for any lighting works. Approval for any works will need to be sought from Scottish Natural Heritage. Three Lighting Consultant firms as recommended by Sustrans have now provided quotes to carry out Lighting Design or Parameters to provide guidelines for seeking Scottish Natural Heritage approval. The summary of the quotes and a breakdown of detail provided in each quote are below. (full details of quotes with all terms and conditions are available)

Please note that the SBC Assistant Engineer has advised any lighting installation for the tunnel at Eshiels would need to be agreed by Scottish Natural Heritage to satisfy them that any artificial lighting would not negatively affect the legally protected bats in this area.

The two quotes from Connected Light and Brent Wood Group seem to provide figures for assisting in this process, with Scottish Natural Heritage seeking an agreement for a principle lighting strategy with parameters and mitigations for this tunnel.

After such a process has been undertaken and if an agreement can be reached, a lighting design would need to be undertaken that satisfies all of the criteria laid out in the strategy. A design would specify the equipment, layout and controls to be used as well as all the relevant information needed to purchase the materials and install the lighting scheme on site.

The quotation from WLC seems to be a quote for a lighting design only, assuming an agreement with Scottish Natural Heritage has been reached.

All three firms were given the same details in the request to quote.

#### SUMMARY OF DETAIL PROVIDED IN QUOTES

## Quote 1 Connected Light

£3750

This is not a quote at this stage but the initial basis for a fee proposal. Review the current proposal and enter into discussion with SBC & Scottish Natural Heritage to gain an understanding of the requirements versus limitations. Draw up a draft proposal and a CAD lighting schematic that meets the legal requirements of Bat Mitigation and ask Scottish Natural Heritage to comment. Changes to design might be requested because no two officers hold the same views. Please be aware that your ideal requirement for high levels of light for pedestrians & cyclists will not be conducive to seeking approval. The light levels will be low to meet the Bat mitigation especially because of the low height of the tunnel.

#### 1) Lighting Parameters

The outline product type strategy based on operational uses and excludes any external lighting associated with landscape feature, building feature and signage illumination.

The lighting parameters are modelled for the Site to achieve the specific lighting requirements for the function and use of the areas. This is supported by a visualised overview of the Site rendered impression and operational illuminance levels achieved.

## RECOMMENDATIONS TO THE TWEEDDALE AREA PARTNERSHIP

#### POINTS TO CONSIDER

Advice on the Lighting Design quotes has been sought from an Assistant Engineer at Scottish Borders Council.

The undernoted advice may be helpful in reaching a decision.

- This would be the first Tunnel within the Scottish Borders Area to be lit during daytime.
- To provide the required amount of light would be approx. 50k Lux and this may not be conducive to the dark area at the top of the tunnel required to protect the bats.
- The total cost of the work required if the Lighting Design/ Parameter is acceptable to Scottish Natural Heritage and the Area Partnership is not yet quantified. A lighting design will need to be agreed and will be subject to variables such as power access, time clock, motion activated or solar power designs. The lighting works cost will be significant and will require further approval.
- There will be ongoing revenue costs and maintenance costs if lighting provision is required.
- The window for any works approved must be Sep-Oct or Mar- April to meet bat regulations. Given the timescales, should approval for the Lighting Design be given by the Area Partnership a cost has been included in the "Small Schemes" agenda item for further approval.

#### OTHER OPTIONS

If the Area partnership wishes not to proceed with the Lighting Design – other possible mitigation works eg reflective paints, could be reviewed. Additional Sustrans signage is also available eg Share with Care
