(2) Telephone and Information Technology (ICT) Expenses: excludes capital costs where the equipment is supplied by the Council and the Council retains ownership of that equipment. These support costs for ICT provision are met by the Council. There is no refund of any of the costs to elected members. The variation in support costs allocated to each elected member reflects the costs of supporting homeworking and annual rental costs for mobile telephones. The balance relates to costs incurred on telephone calls carried out as part of Council activities.

(3) Travel costs for the Leader comprise mileage payments to staff (Car direct) and taxis (Other Travel) taking him to meetings.

Notes:

- 1 Income Tax and National Insurance deductions are made as appropriate.
- 2 Receipts are provided in respect of expenses claimed.
- 3 Costs include VAT where applicable.
- 4 Civic Allowance - The Council Civic Leader (Convener) can incur expenditure up to a maximum of £3,000 to support his activities. No call has been made on this provision in 2016/17.
