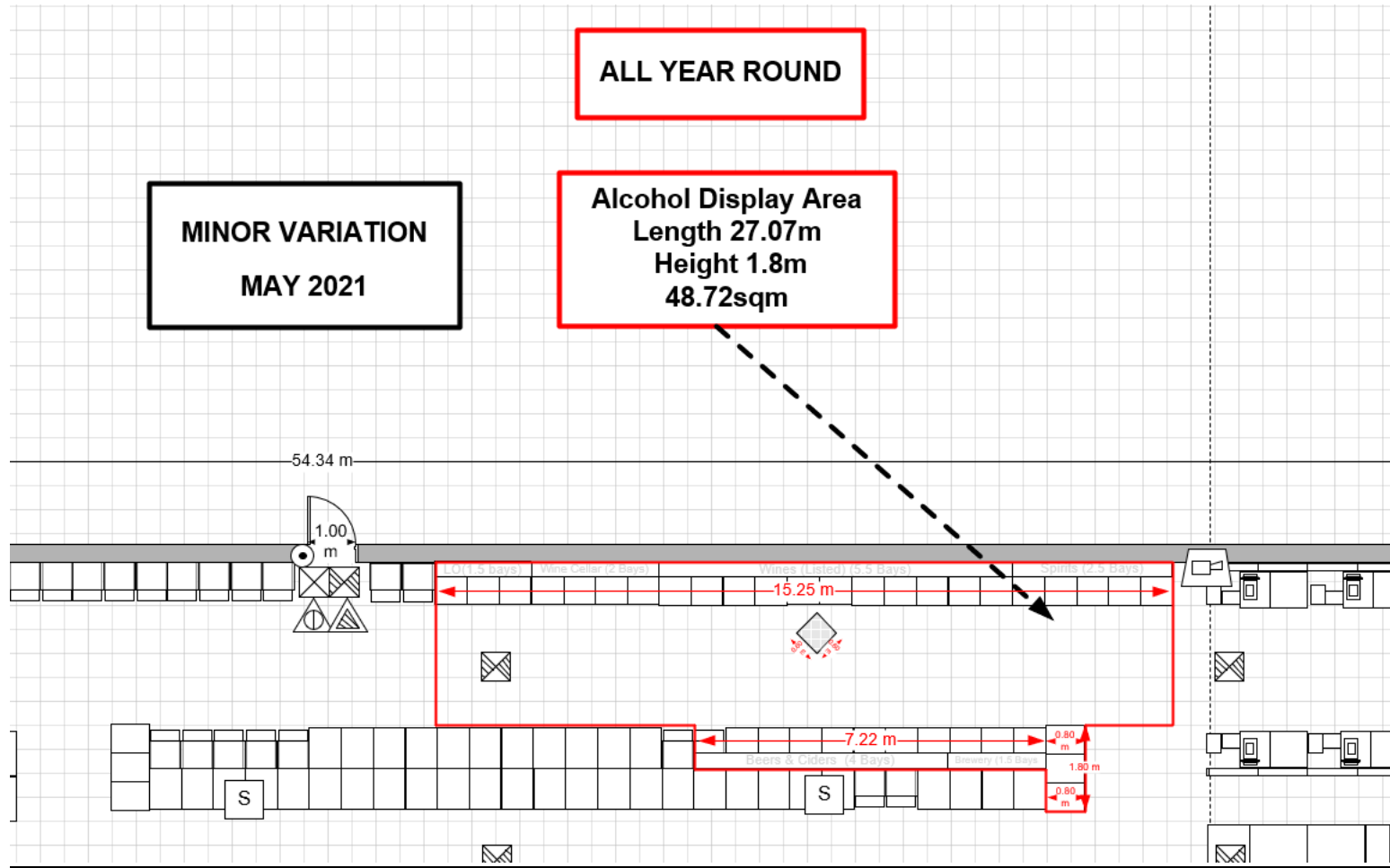

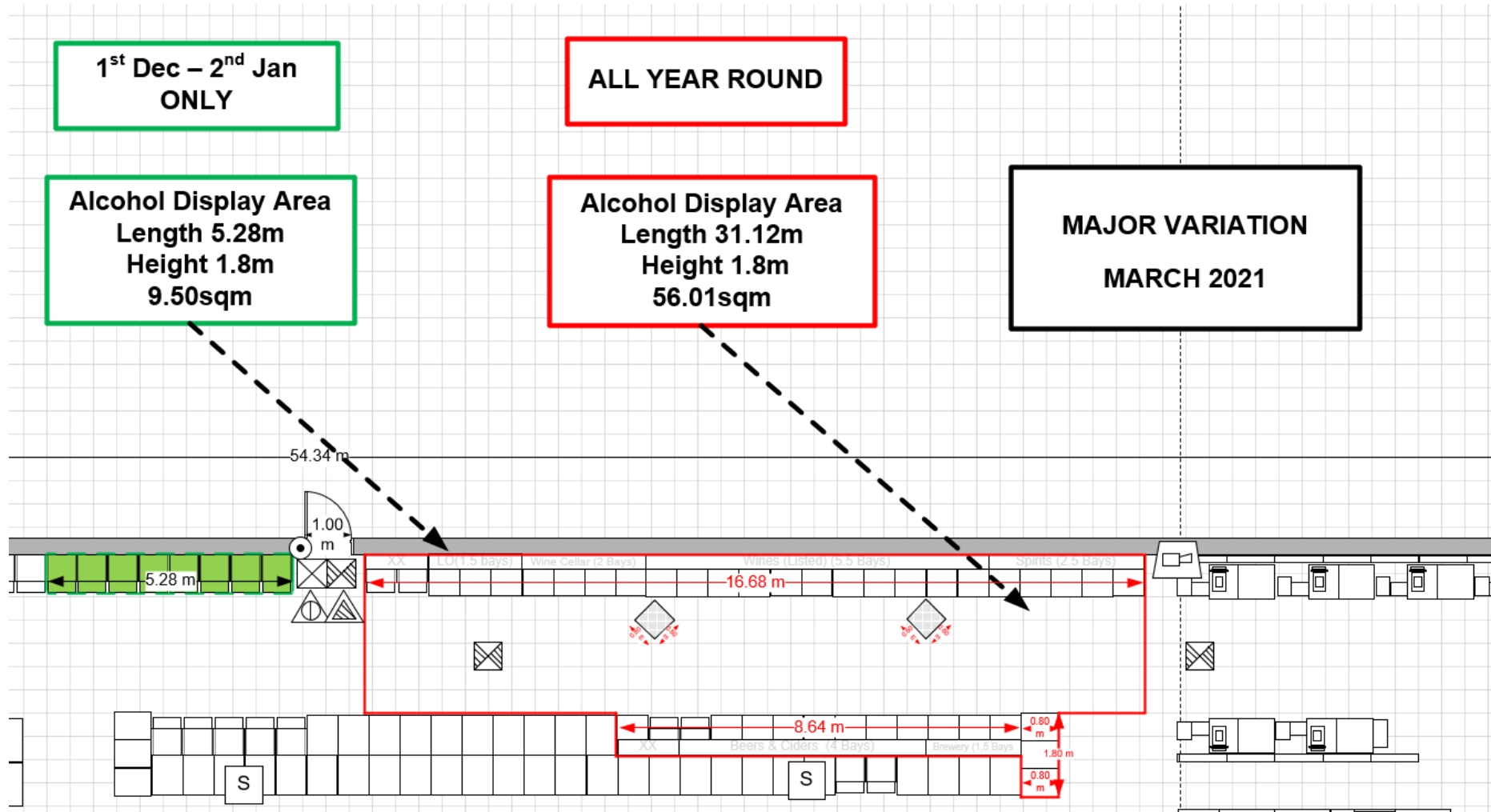

**1564 HAWICK - PROPOSED ALCOHOL DISPLAY AREA**

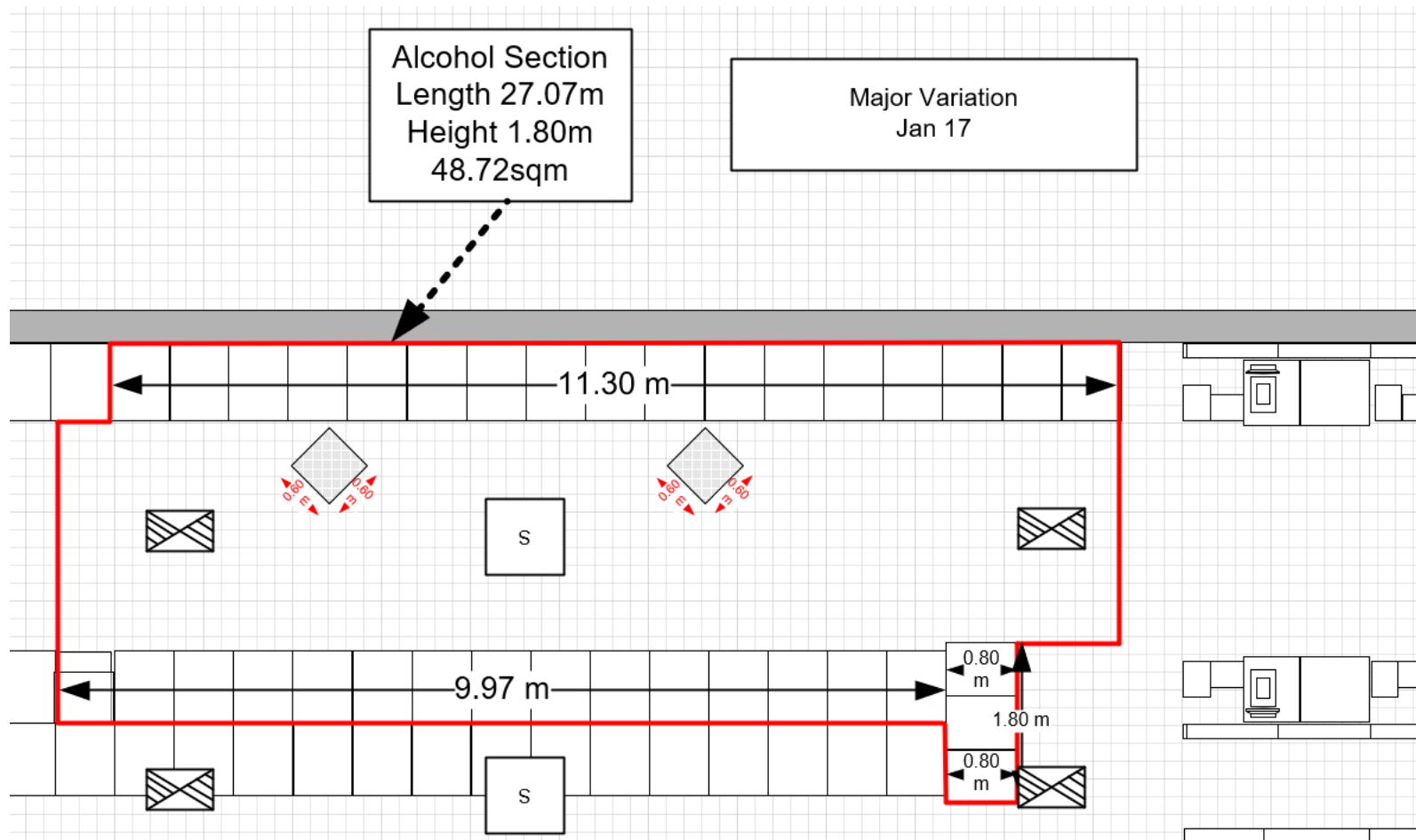
