1. **MINUTE.**

There had been circulated copies of the Minute of 19 February 2015.

DECISION

NOTED the Minute, subject to minor amendment.

2. FINANCIAL MONITORING REPORT

There had been circulated copies of a report by the Chief Financial Officer providing the year end out-turn for the Galashiels Common Good Fund for the year 2014/15 including balance sheet values at 31 March 2015 and proposed budget for 2015/16. The Corporate Finance Manager, Lynn Mirley, highlighted the main parts of the report and referred specifically to the appendices. Appendix 1 to the report provided the actual income and expenditure for 2014/15, which showed a surplus for the year of £5,227 against a budget surplus of £3,575 and projected out-turn for 2015/16. Appendix 2 provided the balance sheet value to 31 March 2015. This showed a decrease in reserves of £5,942. Mrs Mirley explained that all fixed assets of the Common Good Funds were revalued every 5 years as part of the Council's rolling programme. Due to the late approval of the assets for Galashiels these assets were not revalued but would be revalued in 2015/16. Appendix 3 to the report showed the current Net Book Value of the individual assets. Appendix 4 showed the value of the Newton Fund to 31 March 2015 which showed an increase of £569 from the total cash invested. Dividends totalling £183 had been received from the Newton Fund during 2014/15. Mrs Mirley answered Members' questions which related specifically to the interest rate received on cash deposits and the valuation of individual assets. With reference to paragraph 3 of the Minute of 4 September 2014, Members went on to discuss whether, in view of the clarification of income from the Ladhope Trust and the Newton Fund, the Sub Committee should re-commence the distribution of amounts of money in the form of grants and donations. In their deliberations Members took into account the need to retain sufficient accessible funds to service the Common Good Assets. After careful consideration, Members unanimously agreed that grants and donations of up to £3,000 per year from the Common Good Fund should be awarded and that suitable applications be invited. It was noted that, in line with other Common Good Funds, applications should be made only after all other avenues for funding had been explored. In this respect the Chairman had received an enquiry on behalf of the group 'Energise Galashiels' who were seeking financial assistance towards set-up costs to enable the group to become established and self-supporting. It was noted Page 1

that a significant part of these initial costs related to insurance cover which was required to be in place before any activities began. Members indicated their agreement in principle to providing a grant of up to £1,000 to 'Energise Galashiels' should a formal application for funding be received. In view of the urgency of the financial assistance required it was agreed that the final decision on whether to award a grant to 'Energise Galashiels' be delegated to the Chief Financial Officer in consultation with the Chairman.

DECISION

- (a) NOTED the:-
 - (i) actual income and expenditure position for 2014/15 in Appendix 1;
 - (ii) final balance sheet value to 31 March 2015 in Appendix 2;
 - (iii) summary of the property portfolio in Appendix 3; and
 - (iv) current position of the investment in the Newton Fund in Appendix 4.
- (b) AGREED:-
 - (i) that the distribution of awards, in the form of grants and donations from the Galashiels Common Good Fund, be re-commenced with immediate effect up to a total of £3,000 per financial year;
 - (ii) the proposed out-turn in Appendix 1 and the proposed budget for 2015/16, as amended to include a 'grants and donations' budget of £3,000; and
 - (iii) to agree in principle to award a grant of up to £1,000 to 'Energise Galashiels' and, subject to a formal application being received from that group, to delegate the final decision regarding the award to the Chief Financial Officer in consultation with the Chairman.

1 PURPOSE AND SUMMARY

- 1.1 This report provides the details of the income and expenditure for the Gala Common Good Fund for the 3 months to 30 June 2015 and full year projected out-turn for 2015/16 and projected balance sheet values to 31 March 2016.
- 1.2 Appendix 1 provides a projected Income and Expenditure position. This shows a projected surplus of £100 for the year.
- 1.3 Appendix 2 provides a projected Balance Sheet to 31 March 2016. It shows a projected decrease in the reserves of £11,638.
- 1.4 Appendix 3 provides a breakdown of the property portfolio showing actual Income and Expenditure to 30 June 2015.
- 1.5 Appendix 4 shows the value of the Newton Fund to 30 June 2015.

2 RECOMMENDATIONS

- 2.1 It is recommended that the Common Good Sub Committee:
 - (a) Agrees the projected Income and Expenditure for 2015/16 in Appendix 1.
 - (b) Notes the projected Balance Sheet value to 31 March 2016 in Appendix 2.
 - (c) Notes the summary of the property portfolio in Appendix 3.
 - (d) Notes the current position of the investment in the Newton Fund in Appendix 4.

3 BACKGROUND

3.1 This report provides the Committee with financial information for the period to 30 June 2015 and projections to 31 March 16. The report also contains a projected balance sheet for the Common Good Fund to 31 March 2016.

4 FINANCIAL POSITION 2014/15

4.1 Appendix 1 provides detail on income and expenditure for the 2015/16 financial year. The projected net position for the year is a surplus of £100.

4.2 Income & Expenditure – Rental Income

There is no rental income for the properties owned by the Common Good.

4.3 Income & Expenditure - Non-Property Related Income

The projected out-turn includes an estimate for the interest receivable on cash deposited with the Council. This, however, does not show as an actual income until the end of the financial year as amount is dependent on interest rates and the average cash revenue balance invested with the Council over the full financial year. The annual rate of interest applied to the cash deposits is expected to be around 0.4%.

- 4.4 The capital reserve is invested in the Newton Fund and distributions are made twice a year in September and February. The proposed budget for 2015/16 is based on a distribution of 2.5% which will be subject to the overall performance of the fund.
- 4.5 There is no property expenditure projected for 2015/16.

4.6 Income & Expenditure – Grants & Other Donations

The grants and other donations distributed and committed to 30 June 2015 are shown below. There are currently no grants and other donations that have been approved but not yet paid. The Sub-Committee at a meeting on 9 June 2015 agreed in principal to award a grant of £1,000 to Energise Galashiels subject to formal application.

4.7 **Income & Expenditure – Depreciation Charge**

The depreciation charge is projected to be £11,738 based on the valuation of the properties at 1 April 2014. This will change once the revaluation has been completed. This is not a cash transaction.

4.8 Appendix 2 provides the balance sheet value to 31 March 2015, the projected movement in year and a projected balance at 31 March 2016.

4.9 Balance Sheet - Fixed Assets

All fixed assets of the Common Good Fund are revalued every 5 years as part of the Council's rolling programme. Due to the late approval of the assets for Galashiels the assets were not revalued as part of the rolling revaluation program. These will be revalued in 2015/16. Appendix 3 shows the values of the individual properties at 31 March 2015, projected depreciation charges 2015/16 and projected value at 31 March 2016 prior to the revaluation.

4.10 Balance Sheet - Newton Investment

- a) With the current uncertainties in financial markets worldwide caused by the Greek debt crises, speculation over possible interest rate rises in the US and the downturn in the growth rate of the Chinese economy, Global markets have proven to be very volatile in the second quarter of 2015.
- b) This has resulted in a downturn across financial markets, which has averaged 5%. Against this background, information from Newton shows an overall performance reduction of 2.76% indicating a reduction in assets value but a lower level of relative performance reduction compared to the wider market over the quarter. The Newton Fund due to its remit of "capital preservation" has therefore been impacted by market fluctuations to a lesser extent than other funds. It should again be noted that these investments are long term investments and individual quartile performance should not be taken in isolation but must be viewed over the longer term. Newton's have action plans in place and as at the end July recovered 0.8% of the second quarter reduction. They believe the overall objective of the fund to return LIBOR+4% over a 5 year average is still achievable and there is no reason to change the strategy adopted at this point.
- c) The projections include an unrealised deficit of £29 for the Newton Fund Investment as at 30 June 2015. Appendix 4 shows the performance of the fund since inception $\frac{1}{2}$

4.11 Balance Sheet - Cash Balance

The cash held by the fund is projected to be £12,870, an in year projected increase of £100. The projected cash movement for 2015/16 is as follows:

The projections for the Capital Reserves include the unrealised profits for the Newton Fund as at 30 June 2015.

5 IMPLICATIONS

5.1 Financial

There are no further financial implications other than those explained above in Section 4.

5.2 **Risk and Mitigations**

There is a risk that investments in the Newton Fund may reduce in value due to market or investment performance. This risk cannot be fully mitigated, however it is being managed by the selection of a Fund Manager with a clear objective of preserving capital values while aiming to produce returns in line with the benchmark

5.3 **Equalities**

It is anticipated that there are no adverse equality implications arising from the proposals contained in this report.

5.4 **Acting Sustainably**

Whilst there are no economic, social or environmental effects arising from the proposals contained in this report, there are, through the activities reported upon, positive impacts upon the economy through protection of employment, positive impacts upon the quality of community life and improvements in local amenities and nurturing of local talent. The potential improvement in levels of income through the use of the new investment fund will act to make the Common Good Fund more sustainable in the future.

5.5 **Carbon Management**

There are no effects on carbon emissions arising from the proposals contained in this report.

5.6 **Rural Proofing**

There are no effects on rural proofing arising from the proposals contained in this report.

5.7 Changes to Scheme of Administration or Scheme of Delegation
