LAND		
Name of Asset	Location	Description
Brownsbank Park	Brownsbank, Eyemouth, TD14 5DJ	There is no common good declaration in the title but the land was gifted to Burgh for use as public park only in 1962.
Eyemouth Fort	Eyemouth, TD14 5BB	The Fort and the land in which it is erected was gifted by Mrs Home Robertson “for the benefit and enjoyment of the people of Eyemouth” in 1979.
Public toilet	High Street, Eyemouth, TD14 5EU	The land on which the public toilet was erected was conveyed to the Burgh for certain good and onerous causes in 1971.
