MINUTES of Meeting of the BERWICKSHIRE AREA PARTNERSHIP held in Coldstream Community Centre, High Street, Coldstream, TD12 4AP on Thursday, 1 December 2022 at 6.30 pm

ORDER OF BUSINESS

The Chair varied the order of business as shown on the agenda and the Minute reflects the order in which the items were considered at the meeting.

1. WELCOME AND MEETING PROTOCOLS

The Chair welcomed everyone to the meeting of the Berwickshire Area Partnership and to Coldstream Community Centre.

2. REPORT FROM POLICE SCOTLAND

The Chair introduced Community Sergeant Alison Grainger to deliver a presentation on Police Scotland work in Berwickshire communities. Sergeant Grainger advised that there was guidance for police officers to attend Coldstream and District, Duns and Eyemouth community councils while attendance for smaller community councils could be arranged on request. In Berwickshire, there were three community police constables, two based in Eyemouth and one based in Duns. Availability of police officers was affected by resources and Sergeant Grainger advised that community officers would fill gaps in provision affected by response police officers. In response to a question on whether there was enough police officers needed to cover the area, Sergeant Grainger advised that there were generally two police constables to cover each area however the Borders was a challenging local authority area to cover and that the guidance from the Chief Inspector was that Police Scotland should meet needs rather than expectations. Police Scotland were always recruiting and it was advised that the policy of retirement being available for police officers over 50 years-old or with 25 years of service brought challenges to Police Scotland capacity. Road safety and speeding in communities was discussed and attendees raised the possibility of more dragon's teeth road markings being used. Sergeant Grainger advised that she worked regularly with Scottish Borders Council Road Network Team Leader on issues of road safety. Mr Inglis raised the importance for the Page 5

police representation on the Berwickshire Community Safety Panel and Sergeant Grainger advised that she could be contacted by email to discuss possible police attendance. Sergeant Grainger advised that high-risk missing persons contributed to a great deal of work for Police Scotland. It had been observed that mental health issues have increased since the onset of the Covid-19 pandemic and that the impact on incidences of high-risk missing persons required a lot of police resource. The Chair thanked Sergeant Grainger for her contribution and advised attendees that councillors work with Police Scotland and could pass on any messaging through the Area Partnership.

3. FEEDBACK FROM MEETING OF 1 SEPTEMBER 2022

- 3.1 There had been circulated copies of the Minute of the Meeting held on 1 September 2022. Mr Dougie Paterson, Berwickshire Housing Association, advised that he had also been in attendance at the meeting.
- 3.2 With reference to paragraph 8 of the Minute of the Meeting held on 1 September 2022, the Chair advised that Ayton Heritage had already received funding elsewhere and that the panel didn't want to disclose that information before the funding scenario had been clarified.

DECISION

AGREED to approve the Minute of the Meeting for signature by the Chair subject to the change detailed above.

URGENT BUSINESS

Under Section 50B(4)(b) of the Local Government (Scotland) Act 1973, the Chair was of the opinion that the item dealt with in the following paragraph should be considered at the meeting as a matter of urgency, in view of the need to keep Members informed.

4. REPORT FROM SCOTTISH FIRE AND RESCUE SERVICE

- 4.1 The Chair invited Dougie Tait, Scottish Fire and Rescue Service Group Commander for Midlothian, East Lothian and the Scottish Borders to provide an update on fire and rescue matters for Berwickshire. The following statistics of incidences in Berwickshire for the year to date were presented to the Area Partnership.
 - There had been 8 accidental dwelling fires, which caused 3 deaths
 - There had been 48 recorded incidences of other fires
 - There had been 41 non-fire incidences including 19 road traffic collisions, with 3 requiring rescue work with 6 recorded injuries
 - The service had seen an increase of incidences where forced entry was required for partner agencies, there had been 16 incidences recorded.
 - There was a significant recording of unwanted fire alarm signals, there were 91 since the first year quarter.
- An on-call watch commander was introduced to co-ordinate non-fire related work. There were three on-call stations in Berwickshire. The service operated its own community action team which consisted of 4 firefighters and a Local Area Liaison Officer. 48 home fire safety visits for the most vulnerable had taken place. More community activity was able to take place following the ease of restrictions associated with the Covid-19 pandemic which included CPR training at The Hirsel, Coldstream and bonfire safety talks in schools. With regards to skills development in the service, training activity had taken place for flood response. Coldstream station was appointed as wildfire support station following a period in July-August 2022 where there were wildfire incidences in the area. Group Commander Tait advised that the service supports wildfire response in Northumberland. With regards to recruitment, the Duns station saw an increase of personnel from 5 to 10 following targeted recruitment work. Daytime availability of personnel increased from 34% to 80% and there was an aim to increase availability by 25% in Coldstream and Eyemouth. Pre-recruitment opportunities were available for

prospective personnel to meet crew and observe training.

4.3 Group Commander Tait responded to questions from attendees. It was confirmed that damage to Duns fire station caused by Storm Arwen was resolved and the service's business continuity plan ensured that emergency availability was maintained. With regards to reports related to institutional prejudice in the London Fire Brigade, Group Commander Tait advised that he wasn't aware of the situation there, however his experience was that in 25 years of service in Scotland, he had not come across anything like what had been described in the reports of the London Fire Brigade. With regards to fire alarm legislation, the service initially fitted new smoke detectors for high-risk people. Group Commander Tait advised that information on CPR training could be accessed through groups contacting him by email.

DECISION

AGREED to circulate contact details for community groups to access support from SFRS community action team

5. **BORDERS GREENWAY BRIEFING**

- 5.1 The Chair invited Rachel Hardie to present an update on work taking place to establish an active travel route connecting Tweedbank Station with Eyemouth using the route of the old Berwickshire railway. The project started in 2020 when the potential was identified for connecting Tweedbank and Reston stations via the old railway route. There were benefits identified in three categories:
 - People Mental health and fitness benefits in a route with no traffic.
 - Place active travel would have economic benefits for local businesses, and to connect communities.
 - Planet active travel would be beneficial in the context of the climate crisis encouraging a shift from using cars.
- In 2021, a group was formed to advocate the establishment of the route and which put a proposal to South of Scotland Enterprise (SOSE) who provided funding for a Scottish Borders Council-led feasibility study which was reported on in May 2022. The proposal put forward was for a hard-surface buggy/wheelchair friendly path for walkers and cyclists. The accommodation for equestrian use was being debated. In October 2021, a formal community collaboration group was established to work with communities to identify the most feasible route for the route. A walk of the old railway line from Earlston to Gordon had taken place to assess barriers and fencing for reporting to Scottish Borders Council. Community Councils were encouraged to participate in the group and to find out more by visiting https://www.gavinton.net.
- 5.3 Ms Hardie advised the route would be 40 miles-long and that over the course of the old railway line, two-thirds was walkable and access was allowed over three-quarters of the route. Roads were to be avoided as far as possible and final route had not been determined. The Chair thanked Ms Hardie for the presentation.

DECISION NOTED the update.

Councillor Rowley joined the meeting during discussion of the above item.

6. UPDATE FROM NHS BORDERS

6.1 The Chair invited Mr Inglis, Reston and Auchencrow Community Council to introduce the item. A representative from NHS Borders primary care was not able to attend the meeting to address health centre matters. Adelle McElrath, Director of Dentistry of NHS Borders provided an update on dentist provision in Berwickshire and the Scottish Borders. Dr McElrath advised that primary dental care was provided through general services and public services. It was explained that general services were generally provided through

independent, high street-based dental practices. Public services were employed by NHS Borders and provided a safety net which offered services to the vulnerable, children and for emergency care. The Covid-19 pandemic had affected dental provision. There were 16 general dental services in the Scottish Borders and activity was at 84% higher than the national average. Public dental services were working hard to cover unscheduled and emergency care. Recruitment was increasingly an issue for dental services as nurses and receptionists were leaving the service. The establishment of a new dental surgery for Duns was progressing. Advertising for the new surgery couldn't begin until inspections on equipment had taken place. There was a potential for capability of 4,500 patients and registrations were being accepted on their website.

6.2 Dr McElrath advised that due to annual leave and sickness, there was not anyone available from NHS Borders to address the closure of the Chirnside Health Centre.

7. PLACE MAKING

- 7.1 The Chair invited Anne McNeil to present an update on the Duns and District Place Plan development. A meeting on place making in Duns had recently taken place with over people from various local groups. Amongst issues discussed were the desire to look at natural spaces like the park. Feedback also highlighted the desire for face-to-face consultancy to take place with someone that understood the community. It was identified that when data is collected from the community that resource was needed to take forward the work. A Heart for Duns had a part-time development officer led by a voluntary lead officer, however additional resource was needed to take forward place planning. Attendees discussed capacity requirements for communities take forward place making. Ms McNeil advised that a full-time officer could take forward this work and that A Heart for Duns would otherwise not have the capacity to take forward the work.
- 7.2 Attendees undertook table discussions for 10 minutes to discuss taking forward place making in communities.

8. **COAST TO COAST CYCLE ROUTE**

The Chair invited Councillor Rowley to present an update on developments of the Coast to Coast Cycle Route in place of Lena Hutton, South of Scotland Enterprise. Councillor Rowley advised that a soft launch of the route would soon take place and that the concept was for a cycling equivalent of the Southern Upland Way. The route would begin at Stranraer and would aim to go through as many settlements as possible along the route, making connections through scenic roads. The end point was intended to be Eyemouth. The expected time taken for keen recreational cyclists to complete the route would be 4-7 days. The intended impact of the route would be that investment would follow for e-bike storage and other infrastructure. The route has been fully funded and would follow as a legacy of the UCI World Championships which would take place in Scotland in August 2023. Councillor Rowley advised that project would not be an engineering project and that the route would be supported by new signage and a mobile application. Attendees discussed the route, and raised the importance of investing in road quality for cyclists and other users.

9. COST OF LIVING UPDATE

The Community Co-ordinator provided an update on activity and support across the Borders and in Berwickshire in relation to the cost of living. Scottish Borders Council had £1.2 million to support communities and households with the rising cost of living. Some activity was related to food including work with Fareshare and the Low and Slow Project with NHS Borders and Changeworks. BAVS had opened Warm Spaces Fund which used funding from SBC. Ms Amaral of BAVS advised that support had been received from The National Lottery and that applications to the fund were being received. Ms Amaral advised that there had been concerns raised with food distribution and that there had been movement to advocate for a 'cash first' approach. Councillor Anderson advised that feedback had been received from foodbanks for donations of pet food. Attendees raised concern about ongoing impact of the cost of living crisis and what further support there

would be from SBC. This would be dependent on the announcement of local authority funding from the Scottish Government which was due for December 2022. Mr Inglis advised that storage heaters had been switched off in the Reston community larder due to uncertainty of how to pay for heating. Feedback from users indicated that financial support was required possibly to cover food vouchers or money off electricity bills. It was noted that less food was being donated through Fareshare. The Community Coordinator advised that supermarket vouchers were available for distribution and the information to access them could be shared with community groups. Communities and Partnerships advised they would follow-up with community groups with information related to food vouchers and food distribution.

DECISION NOTED the update.

10. BERWICKSHIRE FUNDING TABLE 2022-23

There had been circulated copies of the Berwickshire Funding Table which showed available funding in the Berwickshire area. Communities and Partnership confirmed balances of funds available and noted there were was no applications for funding to be considered at the meeting. The Neighbourhood Support Fund began with £99,997.19 for 2022-23 and that £62,565.64 of funding had been awarded since 1 April 2022.

DECISION NOTED the update.

The meeting concluded at 8.40 pm.

Overall summary of Issues

Positive Feedback from the event indicated the Council is clearly trying to develop the Place Making agenda. The work being undertaken on climate change is

welcomed as is the attempt to engage with communities through these sessions and address the challenges they face.

There are however a number of challenging issues raised as part of the community conservation in Hawick and Denholm Ward. A number of these are thought to be opinions expressed for which no specific action is required e.g. SOSE not forgetting its commitment to projects, or isolated fault issues e.g. street lighting during the day. There are also a number of issues which are subjective individual perceptions e.g. Denholm school a mess.

Overall summary of Issues

General issues of town maintenance, roads, public toilets, parking, Saltgreens - meals, Safe Place scheme, old Eyemouth High School, need for affordable housing

You said	We Propose To
General maintenance around swimming pool, bottle banks, bins, pilot "big belly bins". Make waste bins seagull proof. There are weeds everywhere, footpaths overgrown, inadequate lighting at Deanhead Drive and Road	We are currently reviewing the approach we are taking to neighbourhood management. Each ward area has a small schemes budget which can be used to address issues such as benches, painting railings etc. The Council is trying to develop new approaches to neighbourhood maintenance recognising SBC cannot (regrettably) do everything we would like to and there is huge untapped capacity in localities for volunteers etc. to help with the general upkeep of neighbourhoods. We want to develop a new approach to community engagement and involvement and explore ways in which we can help local people to improve their environment through grants, advice and assistance. The suggestions re new types of bins that are gull proof will be looked at.
Roads - some need resurfacing, Home Arms car park, whole length at back of Murrayfield needs tarmac. Lack of drop down kerbs	We are currently developing a new approach to roads maintenance which allows communities to determine planned road maintenance priorities in their areas. The Council now has 3 jet patchers and one pot master pro active on the road network filling in pot holes but it is recognised more needs to be done to address larger sections of roads which require resurfacing.
Warner Park - nets and fencing needs repaired, parking issues	We are currently reviewing the approach we are taking to neighbourhood management. Each ward area has a small schemes budget which can be used to address issues such as benches, railing etc. The Council is trying to develop new approaches to neighbourhood maintenance recognising SBC cannot regrettably do everything and there is huge untapped capacity in localities for volunteers to help with the general upkeep of neighbourhoods. We want to develop a new approach to community engagement and involvement and explore ways in which we can help local people to improve their environment through grants, advice and assistance.
Food supply at Saltgreens	The Council wants to ensure residents in all our care homes have access to the best quality food and continually review the quality and affordability of products provided by our suppliers. A recent pilot arrangement in schools using local supplier to provide butcher meat has proved to be very successful and we are looking at ways in which this approach can be rolled out.
Safe place scheme - not just for LD cases	We are in agreement for the need of safe places and we are exploring how we can become part of the Safe Place Scheme.
No public toilets at Reston car park	We have delivered multi million pound upgrades to parks in a number of our communities in recent years. If a park for Reston is a priority then this should be raised via local councillors so that it can be added to the list of future schemes that may be undertaken.
More money should be spent on tourism in Berwickshire	We would love to spend more money on tourism, regrettably this has to be prioritised against other issues. There is a community fund and a Coastal maritime fund which may be able to provide some support. We are also engaging with SOSE and the Gunsgreen house trust to look at investment requirements at Eyemouth harbour.
Eyemouth HS - what is happening with old High School and play park and tennis courts	A plan for the redevelopment of the old High school site is being prepared by Council officers and will be subject to future community consultation.
Toilets in Eyemouth in poor condition	A report on the future provision of toilets is being developed for consideration by members. This may involve rationalising the number of public toilets we have across the region. We have too many and cannot afford to operate and upgrade them all. This is a non statutory service and we need to prioritise where we can invest and sustain services. In the future we may have fewer but better facilities.
Social enterprise - gluten free bakery at risk of losing grant, needs a property	This issue has been resolved and the bakery is now occupying alternative premises.
Allanton - 20mph - concerns over speeding, parking on pavements, school bus safety. Speed on New Harbour road Eyemouth	The Council has introduced a trial 20mph speed limit scheme in many communities and is currently consulting on the future of this scheme. If there is a desire to see more roads included as part of this scheme then this could be looked at, subject to the outcome of the consultation.
Continued partnership with Harbour Trust	The Council has an excellent relationship with the Harbour trust and supports their ongoing activities both financially and in kind. We wish to see this relationship develop in future, building on the success of the EDF investment in the harbour and the expansion of the marine servicing base.
Number of holiday lets stopping local residents finding affordable housing	The Council is working with local RSL partners through the Strategic Housing Improvement Plan to enhance the number of local affordable houses. We recognise this is a major issue for local people. We can use use powers under council tax legislation to levy an additional tax on second homes, however is a private decision for individuals if they wish to own and let out a second home in an area. We will discuss this further with Scottish Government to see if there are ways we could acquire more homes for public ownership when they come onto the open market.
Healthcare provision, GPs and dentists - not good	Not a responsibility of SBC. Will be raised with NHS Borders and the IJB.

Report of Neighbourhood Support Fund Assessment Panel BAP Meeting on Thursday 9th February 2023

Introduction

This paper outlines the recent work undertaken by the Assessment Panel for the Berwickshire Area Partnership, Neighbourhood Support Fund. It gives a brief description of various activities and a review of recent applications. It goes on to make recommendations for consideration by the BAP.

Berwickshire Neighbourhood Support Fund 2022/23

Berwickshire Area Partnership, Neighbourhood Support Fund, Assessment Panel (NSF AP) met for the third full meeting of the financial year, between 1pm and 3pm on Friday 20th January 2023. Approximately £100k was available for distribution through the Neighbourhood Support Fund during 2022/2023. Following the awards made in the first two rounds of funding this year circa £33k remained.

Initially there were 38 applications to this round, however during the process two were withdrawn. The panel were faced with assessing 36 applications, to a value of just over £121k. To put this in context this was more than twice the previously highest number of applications for a single round. It also resulted in a very significant shortfall in the funding available. In summary only between a third and a quarter of applications could be funded, irrespective of their merit.

It is good to know that communities have become more aware of the NSF and have made record numbers of applications. It is however worrying that many deserving applicants will be disappointed that their strong applications did not receive support. It is hoped that these record numbers of quality applications will be recognised when setting the NSF budget for next year.

Changes in the Guidance Notes

Following round two of the assessment process, in September 2022, further clarification was made to the NSF Guidance Notes. It now states that:

• The fund provides support and assistance with the development of community-based projects for voluntary and community groups that are active in their local area. We wish to encourage applications with clearly defined outcomes that can be delivered within stated timescales.

• Funding can be used for a variety of purposes (see guidance notes). It is less likely that the Neighbourhood Support Fund will be used to support ongoing activity and general staff support, unless there are very compelling justifications for doing so.

Changes in the Application Form

Earlier in the year some minor changes to the application form were introduced, to simplify it and streamline the assessment of submissions. These changes have been largely successful. Unfortunately, it has not been possible to introduce an on-line version of the new version of the BAP form this year, but we are hopeful that this will be available soon.

Additional Panel Members

We are pleased that two new members have joined the Assessment Panel this year: Kathy Huffman and Jim Hettrick. Unfortunately, Anne McNeill, who has been key to the development and implementation of our assessment process, has decided to step down. We all want to thank Anne for invaluable contribution to our work over the past 2 years.

In view of the need for four voting members for the panel to be quorate, there is always a need to recruit additional members and attain a full complement of panel members. Attaining full delegated powers for the Assessment Panel

At its meeting on 4th March 2021 the BAP agreed to the following recommendation: "We recommend the creation of a sub-subcommittee of the BAP with full delegated powers to undertake the assessment of applications and subsequently make awards."

At the BAP meeting 9th June 2022 our recommendation that "the Neighbourhood Support Fund – Assessment Panel receives full delegated powers to make and communicate its decisions to applicants" was again endorsed by the BAP.

We would like to uncouple the work of the Assessment Panel and the BAP and move to three equally spaced application periods on an annual basis. We could then publish these dates well in advance and deal with applications more timeously.

Assessment of Applications

I have outlined below the assessment process:

- The Assessment Panel members involved were Keith Dickinson (Chair), Anne McNeil, Andrew Mitchell, Kathy Huffman, Jim Hettrick and three councillors: John Greenwell, Mark Rowley and James Anderson.
- Recognising the need for transparency, panel members made declarations of interest related to a number of applications.
- Prior to the meeting SBC officers checked that applications complied with the published Eligibility Criteria.
- In view of the record number of applications, each was initially scored and ranked by three panel members.
- Where there was an identified difference between the initial three rankings, a fourth marker assessed and ranked the application.
- Applications were blind marked, according to the published criteria and SBC officers tabulated and circulated all marks and rankings prior to our meeting.
- Initially a group of applications that were highly supported by all who had assessed them were considered. After due consideration all were considered worthy of support and of high priority.
- A second group of applications, that were broadly supported, were considered and provisional recommendations made.
- Before final recommendations were made panel members were given the opportunity to consider in detail any of the remaining applications.
- There were clearly applications that were considered fundable but considered to be of a lower priority and they could not be supported due to the funding constraints.
- The volume of applications, this funding round, tested the process and the panel. However, although the assessment task was demanding, we moved relatively smoothly to a consensus and agreement on our recommendations.

The minutes of the assessment panel meeting can be seen in **Appendix 1** below, which includes a brief description of applications considered and some individual feedback from our deliberations. Our recommendations are summarised in **Appendix 2**.

Summary of Recommendations

1. It is recommended that BAP approve the awards detailed in Appendix 2

1. WELCOME

The Chair welcomed everyone to the meeting and outlined the content to be covered during the meeting. The Chair confirmed the withdrawal of two applications from this round of funding.

2. MEMBERSHIP OF THE ASSESSMENT PANEL

The Chair confirmed that AM is stepping back from her role on the panel and thanked AM for her contribution in helping establish the panel and the process of assessing applications.

3. PROCESS OF APPLICATION ASSESSMENT FOR ROUND 3

The Chair outlined the approach that had been devised to manage the assessment of 38 applications and ensure that the appropriate level of assessment was maintained. All applications were initially scored and ranked by three panel members. Where there was an identified difference between rankings, a fourth marker assessed and ranked the application.

4 DECLARATIONS OF INTEREST

Panel members had previously confirmed any interest in applications and marking was assigned to panel members to accommodate this.

5. FUNDING REQUESTED AND FUNDING AVAILABLE

SBC confirmed that 38 applications had been received, but two had been withdrawn. 36 applications with a total request of £121,300 would be considered. A budget of £32,931.55 was available. This did not include ring-fenced funding for Horse Time which had been granted funding in 2021/22 on the condition of a successful evaluation of another project they had received funding for. The panel did not have the time to consider Horse Time's evaluation due to the date of its submission. The Chair proposed that the evaluation for Horse Time and a second grant be considered at the next meeting.

6 OVERALL REVIEW OF MARKS AND RANKINGS OF APPLICATIONS

The Chair shared an overview of application rankings based on the panel's scoring. The ranking was used to show the level of support for each application

and provide a starting point for discussing the applications. Initially a group of applications that were highly supported by all who had assessed them, were considered. After due consideration all were considered worthy of support and to be of high priority. A second group of applications that were broadly supported were considered. However, before final recommendations were made panel members were given the opportunity to propose that any of the remaining, lower ranked applications, should be further considered in detail. The following section provides some detail on the applications that are recommended for support. Appendix 2 shows the total list of applications assessed and the funding recommendations.

7 PROJECT ASSESSMENTS

GORDON COMMUNITY SPORTSFIELD

An application from Gordon Community Sports field requesting £5000.00 was received to help acquire and manage the sports field in Gordon, which is currently privately owned. They will develop its use as the hub for outdoor, sporting and community activities in Gordon.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £5000.00. The panel were supportive of the aims of the group and commented on the level of community support this project has and the long term legacy. Granting them an award would provide the applicant with full project costs allowing them to complete their project.

BORDERS POTTERY

An application was made, requesting £4829.00 to buy equipment that will enable the applicants to offer growth of numbers and allow access to the pottery classes for people with mobility difficulties.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £4829.00. There was a view that this model has potential to develop in to a social enterprise business and generate income from the pieces being produced which the panel were supportive of.

ABUNDANT BORDERS

An application was made, requesting £3636.00 for a project which will work with people in East Berwickshire to reduce poverty and food insecurity by teaching skills required to make healthy, inexpensive meals in fuel efficient ways by using, for example, slow cookers.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £3636.00. The impact this project will have, and the contribution it will make, resulted in the application being scored highly by the panel who considered Abundant Borders to be delivering excellent work in the Berwickshire area.

COLDSTREAM HEART RHYTHM

An application was made, requesting £2250.00, to buy a defibrillator, training materials and consumables to promote health and save lives in Coldstream community.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £2250.00. This project scored highly due to the evidence of community backing, support from health practitioners, the group's long term plans for maintaining the defibs, the planned roll out of training and the importance of having these assets in a community.

BORDERS WOMEN'S AID

An application from Borders Women's Aid requesting £1080.00 was received to enable groups accessing their service to attend wellbeing groups, to relieve isolation, gain peer support and learn new skills

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £1080.00. The panel felt this was a strong application from an organisation with a proven track record of delivery and that this project was based on a model successfully delivered elsewhere.

A HEART FOR DUNS

An application was made, requesting £5000.00 to develop a community website to complement their Town trail and include an events calendar and social media presence.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £5000.00. AHFD has a wide reach and the panel were of the view that this is a sensible project to be supporting which would provide value for money. It was commented that the impact AHFD has on the Duns community is visible.

PARENT SPACE

An application was made, requesting £3752.10 to give parents across Berwickshire more access to quality advice, information and support along with one-to-one support.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £3752.10. The panel were supportive of the capacity building and 1:1 support that this project will support and commented on the fact demand for this service is increasing. There was reflection that courses are always well managed and well attended with continued support for parents who participate.

AYTON CHRISTMAS LIGHTS

An application was made, requesting £945.00 to help continue the provision of Christmas lights in Ayton village.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £945.00. There was discussion amongst the panel on whether there were other way the group could raise funding but overall, there was support for this project.

DUNS RUGBY FOOTBALL CLUB

An application was made, requesting £3500.00 to fund more kit and storage to enable more families and children to participate.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £849.45 which is the balance of the NSF. This was a well written application from a club which has good uptake from young people from a wide geographical area. The application scored lower than the other applications as the presentation of their priorities could have been stronger.

DUNS FOOTBALL CLUB

An application was made, requesting £1000.00 for guttering and flashings to finish off the club's new roof.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £1000.00. For a modest sum this will allow for the completion of the project. The local business community has invested time, money and materials in to the club and the panel were happy to also contribute to realise the community benefit this project will provide.

BIRGHAM COMMUNITY DEVELOPMENT TRUST

An application was made, requesting £4590.00 to replace an existing small pavilion in Birgham's recreation park to ensure a safe and protected seating area.

Decision NOTED that:-

It was agreed to recommend that the Berwickshire Area Partnership award a grant of £4590.00. There was discussion amongst the panel on the community impact of this project but on the whole the panel were supportive of the overall aims of the project and the encouragement this provided for outdoor activity and community engagement.

8 DECISIONS AND REPORT TO AREA PARTNERSHIP

Consideration was given to how to present the panel's recommendations given the volume of applications received and that providing detailed feedback on all applications would not be possible.

9 MEETING OF THE ASSESSMENT PANEL TO REVIEW 2022/23 FUND

The panel are confident in the assessment process that has been developed following minor adjustments that have been made this financial year. The volume of applications this funding round tested the process and the panel are happy with the outcome. The panel has no recommendations to make to the Area Partnership for any further changes to the application and assessment process.
