I am unable to support this proposal on the grounds of road safety. Hill Terrace, serving the site, is not suited to serving another dwelling. There are issues with the geometry, surfacing, gradient of the access road and visibility available at the junction with the A7 which cannot be improved to the standard to enable it to serve any more development. Furthermore, poor parking provision in Hill Terrace impacts on availability for vehicle turning and the narrowness of the initial length of access road from the A7 means that vehicles cannot pass each other and access for larger vehicles is extremely difficult.
