Conference Facilities - We have the facility in our first floor function rooms to offer meeting & conference facilities. These traditionally take place during standard office hours & therefore would precede commencement of normal licensing hours.

Bar Meals - we may wish to provide service of breakfast before 11.00 am.

Receptions - we have the facility to offer a wide range of reception facility. This may include funeral parades that require alcohol on the premises from 09.00 am, subject to an expediently processed extended hours application being granted.

Club meetings - we have the facility to host local community meetings. This may include events that require alcohol to be available on the premises from 09.00 am, eg Golf day. This would be obtained through an extended hours application

Recorded music - this may be played outwith core hours during breakfast, or to accommodate private functions or club meetings

Televised Sport - we anticipate that certain major sporting events e.g. Olympics; Football World Cup may be televised outwith core hours and we would wish to offer the sale of alcohol on the premises at these times. This would be obtained through an extended hours application. It would not be shown after core hours without an extended hours grant.

Outside drinking facilities may be permitted outwith core hours in conjunction with other permitted activities.




