The estimated cost to provide panelling in the underpass at the foot of the canongate is £2850. That is based on strapping the wall with 2 x 1 sawn to allow air around the timber and provide fixings for the ply, 12mm marine ply for the face and a timber surround to enclose the ply and framing . There is provision in the estimate for a basecoat to be applied to all timber/ply .
