THE DECISION TO ROLL OUT INCREASED PROVISION OF NURSCLY HOURS BY CATCHMENT AREA IS DISCRIMINATORY. YES, THE FEN STREETS OF MORE 'DEPRIVED' FAMILIES ARE INCLUDED BUT SO TOO ARE SOME OF THE MOST AFFLUENT STREETS IN OUR SMALL TOWN, REJOERING THE 'TARGET DEPRIVED AREAS FIRST' DIRECTIVE AS MEANINGLESS. THIS WAS PLEDGED IN 2014 AND DUE IN AUGUST 2020 WHICH MEANS THERE HAS BEEN AMPLE TIME TO PREPARE.
