The premises may also be used for youth activities such as pre and after school clubs and youth clubs, any time the premises are being used for such purposes the bar will be shuttered and not accessible.

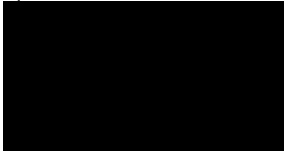
