

# 75th ANNIVERSARY VE CELEBRATION FUND

# **Report by Service Director Customer & Communities**

#### 1 PURPOSE AND SUMMARY

- 1.1 This report proposes the creation of a VE Celebration Fund to be launched on Monday 24<sup>th</sup> February 2020, to enable non-profit making community/voluntary groups, schools and churches to apply for funding to undertake special celebratory projects to mark VE Day.
- 1.2 Awards up to a maximum of £2,500 will be available and to enable these to be processed quickly and efficiently on a fast track basis, it is proposed that decision-making should be agreed at Officer level, with final approval and sign off by the Director of Customer and Communities.
- 1.3 It is proposed that each Area Partnership will contribute from their Community Fund on a per-head of population basis to enable a fund of £60,000 to be created.
- 1.4 The VE Celebration Fund will close on 31st May 2020.

#### 2 I recommend that

- 2.1 Approval is given to the creation of a VE Celebration Fund of £60,000 which is funded on a per head of population basis from each Area Partnership's Community Fund.
- 2.2 Approval is given for decision-making for the Council's VE Celebration Fund to be agreed at Officer level, with final approval and sign-off by the Director of Customer and Communities
- 2.3 That a report detailing the evaluation and outcomes of the VE Celebration Fund is brought back to Executive in late 2020.

#### 3 BACKGROUND

- 3.1 Victory in Europe Day, generally known as VE Day in Great Britain, is a day celebrating the formal acceptance by the Allies of World War II of Nazi Germany's unconditional surrender of its armed forces on May 8, 1945
- 3.2 To commemorate the 75<sup>th</sup> Anniversary of VE Day, it is proposed that a VE Celebration Fund is created to enable communities within the Borders to apply for grant funding to take part in special celebratory events/community projects.
- 3.2 The fund will be open to community councils, schools, community/voluntary organisations based in the Borders and Churches based in the Borders whose project/activity is for the benefit of the wider community (see attached Guidance Notes and Application Form). Projects will be required to meet a minimum of one of the following criteria:
  - Communities have more opportunities to come together to celebrate VE Day (for example, through events, concerts, open days, street parties etc.)
  - Communities have more opportunities to create a lasting legacy of VE Day (for example, improving public spaces, playparks, community gardens etc.)
- 3.3 Typical grants (based on the analysis of the previous Queen's Diamond Jubilee Fund) are expected to be in the region of £1,000, but grants up to a maximum of £2,500 will be considered for larger projects or for projects that create a lasting legacy of VE Day.

#### 4 IMPLICATIONS

#### 4.1 Financial

- (a) The VE Celebration Fund of £60,000 will be created by each Area Partnership contributing on a per-head of population basis from their Community Fund.
- (b) The per head of population contribution has been calculated as follows:
