Karen has taken on a position assisting our youth trustee as a Youth Rep for Scotland and her aim is to grow interest in that area. It is vital that suitable premises are available for use and allow young people to train.
- Karen Milne is currently enrolled on the judge training program and has completed
 phase 1 under the supervision of our only international judge Fi Pugh. Karen is training
 to be a National Judge for Icelandic Horse competitions and plans to hold more regular
 competitions at West Tarf.

I write to give full support to the application submitted by Mr and Mrs Erlend Milne to build a house and workshop at West Tarf. The proposal will secure the existence of the track in the long term and the relocation of a successful rural business can only bring benefits to the local area. The site of the proposed house and workshop is adjacent to other houses along a surfaced road with easy access to the riding track. Development at that location will have minimal impact on any neighbours.

The track would be a valuable asset to Erlend's saddlery business, as a horse could be ridden in any weather in all gaits and at all speeds when the saddle was being fitted, and all necessary adjustments carried out in the workshop on site, thus avoiding all the usual return visits for saddler or horse.

In addition, the track is one of only two oval and pace tracks in the UK that meets the standard requirements for Icelandic horse competitions (under international rules set by FEIF which is the International Federation of Icelandic Horse Associations); the other being in Dorset. It is the only facility in Scotland where young riders can train to national and international standard.

West Tarf has hosted the British Championships of the Icelandic Horse Society of GB (IHSGB) every second year since 1994, bringing competitors and judges from all over the UK, Europe and Scandinavia. This event (which is the qualifying competition for the British team for the World Championships for Icelandic Horses), and other local competitions and training seminars bring competitors and visitors to the Scottish Borders using accommodation and local amenities and this is something that Karen and Erlend want to continue and build on.

Karen is training to be a National Judge for Icelandic Horse competitions and plans to hold more regular competitions at West Tarf. The tracks are also available for use to anyone in the local community as an all-weather training facility for athletic track events.

The track and show field require a substantial amount of maintenance work throughout the year and this is becoming an increasing problem for us as the current owners as we are getting older and have plans to retire into the village. We have considered returning the track and adjacent show field to agricultural use, which would be a great loss.

I own horses which currently graze in the surrounding fields, whose care Karen would take on responsibility for. She is also keen to continue the breeding programme with our current stallion and possibly restart Riding for the Disabled activities here.

It would be necessary to live on site for any of these things to be possible and for Erlend to provide overnight accommodation for horse clients coming from a distance for saddle fitting.

If planning is successful, we will sell Karen and Erlend Milne the site for the house and workshop and arrange a 20 year lease for the oval track with an option to purchase for a nominal sum at the end of the term and also rent a field for grazing adjacent to the site.



I write to give full support to the application submitted by Karen and Erlend Milne to build a house and workshop at West Tarf.

- This proposal will secure the existence of the oval track in the long term. It is the only oval track in Scotland which meets the international standard requirements for Icelandic horse competitions and is one of only two tracks in the UK (the other being in Dorset) currently available for hosting British Championships. West Tarf has hosted several British Championships of the Icelandic Horse Society of GB (IHSGB) since 1993, bringing competitors and judges from all over the UK, Western Europe and Scandinavia
- The Icelandic horse is a unique breed originating from Iceland and has two gaits not normally found in other breeds. Because of this, The Federation of Icelandic Horse Associations (FEIF), of which the IHSGB has been a member since the late 1980's, has its own sport competitions specifically for this special breed and they have to be ridden on a 250m oval track. The track at West Tarf is one of a very few in the UK and the only one in Scotland. It is a popular venue, and it would be tragic for the IHSGB and for Icelandic horse enthusiasts generally, in Scotland and in the rest of the UK, if this track should be lost to us.
- As the UK's only FEIF international sport judge for Icelandic horse competitions, I am well aware of how important the track at West Tarf is to Icelandic Horse Sport in the UK and to the IHSGB. Without it, the IHSGB, which is the governing body of Icelandic horse sport in the UK and a registered charity, would struggle to hold regular competitions and training events. Our Scottish riders are important to us. The IHSGB was founded in Scotland and many of our members live in Scotland. One of our Scottish members, Aidan Carson, travelled to Berlin to represent Great Britain at the World Championships for Icelandic Horses as a member of our national team in August this year and won two silver medals in the Young rider classes. This was a first for Great Britain and a huge achievement for Aidan. The track at West Tarf has played an important part in his journey from child rider to a member of the British team.
- Karen Milne is currently the Youth Rep for Scotland and wishes to continue to encourage interest in lcelandic horses in that area. It is vital that premises are available for use that will enable young people to train and compete on suitable facilities.
- Karen Milne is currently training to be a National Judge for Icelandic Horse Sport competitions, and I
 am in full support of Mr. & Mrs. Milne's plans to hold more regular competitions at West Tarf. The
 oval track draws riders and visitors not only from the surrounding area, but also from all over the
 UK, from Shetland to the south of England, and from Wales. We invite visiting judges from Europe
 to judge our competitions and they are always pleased to have the opportunity to visit the
 surrounding area before they travel home again.

I have utilised Erlend's saddlery skills for a number of years, he is a well-respected saddle fitter with an excellent reputation which means he's very popular and has a client base throughout Scotland and into England. As a client this means that I often have to travel to various riding schools and private yards throughout the Borders and Lothian so that Erlend can make best use of his time and see a few clients in one location. This is far from an ideal situation as the facilities vary greatly and the horses can be tense and spooky in a new environment. Therefore, being able to travel to a purpose built workshop, with the correct facilities, on a regular basis would be a huge improvement for Erlend's clients. It would also mean that he could potentially see clients more timeously as he would spend less time on the road travelling.

As the owner of an Icelandic horse I also have a vested interest in ensuring the longevity of access to the oval track at West Tarf. Not only is it the only one in Scotland, it is also considered to be the best oval track in the UK. There are just 2 purpose built training and competition facilities for the Icelandic horse in the UK, the other one is in Dorset, so they are geographically wide-spread. Karen has extensive knowledge and experience of Icelandic horses and has competed successfully at the British Championships. She is currently training to become a qualified judge which would mean that more competition events could be held at West Tarf. I have been a customer of Erlend Milne for around twenty years. Erlend has visited our livery yard for saddle-fitting on a number of occasions over the years. This is convenient for local horse owners; however, I recognise that Erlend loses productive time when travelling long distances and then we have the logistical challenges of returning adjusted or re-flocked saddles back to him.

On other occasions, my daughter and I have travelled to see Erlend in the central belt. We sought his expertise when our horse was injured and required remedial work after a period of recuperation. By travelling to Erlend, we are able to benefit in other ways.
