The applicant presents this appeal on the grounds that he fundamentally disagrees with the Planning officer's recommendation to refuse planning permission.

It is the applicants contention that the proposal represents an acceptable development of the site and would not adversely impact on Town O' Rule Farmstead, surrounding landscape or indeed the character of the countryside. The proposal would provide a cohesive scheme through its layout, design and materials for the house and ancillary buildings and will enhance the existing building group.

The applicant has worked hard to amend the proposals in line with the Planning Officer's comments and considers that the proposal would be a positive addition to the site and the wider area. It is the applicants contention that the proposal should not have been refused and is wholly compliant with policies HD2 and PMD2 of the Adopted Local Development Plan and Supplementary Planning Guidance on New Housing in Borders Countryside (2008) and Place Making and Design (2010).

In addition we submit on behalf of the applicant a Grounds of Review Statement that provides further evidence to support this review.

A Preliminary Bat Roost Assessment and Extended Phase 1 Habitat Survey, November 2019 has been done and is included within this review. This was in addition to the initial survey which was undertaken by Sarah Hawes - Grad CIEEM on 14th June 2019, with subsequent bat activity surveys undertaken in August and September 2019. These have been submitted as part of this review.

The Preliminary Bat Roost Assessment and Extended Phase 1 Habitat Survey, November 2019 was was received after the decision notice had been issued by the Local Planning Authority.
