

HAVE YOUR SAY

Key points

- The Council manages a five-year revenue budget of around £1.3billion and a 10-year capital budget of almost £300million.
- Our revenue budget is funded by a grant from the Scottish Government and around 20% from Council Tax. Every year this budget is squeezed by the effects of inflation, pay awards, reduction in grants, and new things we're asked to do by the Government as part of the budget grant.
- Like every council we face financial pressures, with a finite amount of resources. We need to balance the demands for increasing spending in some areas eg the care of older people, by making savings in other areas. We are also investing heavily in areas that are important to our communities, such as new schools and early learning and childcare facilities and roads.
- We continue to focus on modernising our approach to delivering all our services and ensuring that they are as efficient and effective as possible.

1. There are a number of significant challenges facing the Council and the Scottish Borders generally, as set out in our recently refreshed Corporate Plan. Many of these are interconnected.

The Council, through its budget, services, projects and its influence and work with partners, has the opportunity to try and tackle these. But to help us prioritise action we want to know which are most important to you.

Please rank the following in order of your priority - highest priority at the top

Demography - we have a falling population, with young working age people leaving, and an increasingly aging population. This results in fewer workers and more older people to support. This has significant wider economic impacts and cost implications for the Council

Economy - the average wage is lower in the Borders than the Scottish average. Due to Covid-19 large parts of the economy have suffered unprecedented disruption and the region is heavily reliant on a small number of sectors, such as hospitality, visitor services and food and drink, which have been among the most severely affected.

Environment/Climate Change - Scotland as a whole has a 75% emissions reductions target for greenhouse gases by 2030, and a net zero target by 2045. The Scottish Borders must play its part in meeting these targets.

Health and Social Care - the number of over 75s is expected to increase by 33.5% in the Scottish Borders by 2026. This means more Borderers will be living with one or more complex health conditions and are likely to require more health and social care as they age. The Covid-19 pandemic has impacted on people's mental health, placing increased demand on support services for all ages.

Skills, Training, Employability and Transitions - unemployment more than doubled between February 2020 and April 2021. There are significant skill shortages which results in long term vacancies

Transport - around 10,000 people in the Borders are not connected to the public transport system at all, and for those that are the costs are high compared to urban Scotland. There are poor east/west links within the region and across the south of Scotland. There is a heavy reliance on private car use

Vulnerable Communities - the reliance on a small number of business sectors, a relative lack of business infrastructure and lower digital connectivity compared to urban areas makes the Borders more vulnerable than many other areas of the country.

2. As one of our biggest services, we spend around a third of Council resources on Education.

There are a number of legal requirements such as pupil/teacher ratios which impact on the flexibility of how the budget can be spent.

However you can help us prioritise the following education and skills areas, and associated budget allocations, by ranking in order of your priority - highest priority at the top.

Access to high quality outdoor learning spaces

Access to training for adults in line with current and future local job opportunities

Closing the poverty-related attainment gap

High quality, modern school buildings

Supporting young people's mental health and wellbeing

Widening digital learning skills and opportunities

3. Our Infrastructure and Environment section also receives a significant annual budget (around £44m/year of our revenue budget) to deliver a huge range of services including roads, property and asset management and maintenance, waste services, grass cutting, public transport and flood protection.

A significant proportion of our capital budget is also connected to this area (almost £80m over three years).

4. An annual programme of works is developed each year to address priority road repairs and is based on our regular inspections of routes and other critical information/guidance. This has to be balanced with reactive repairs and short term fixes.

Due to the complexities involved in developing the programme it is not possible for the Council to open this up to public prioritisation. We do try to ensure that all localities benefit from the works.

There are a range of elements to our roads service however and we would like you to provide your feedback on how you would prioritise these different areas of the service. This will help us to review the current prioritisation of these different elements of the service and allocate available budget accordingly.

10. As part of the drive towards net zero emissions there is a national target of recycling 70% of household waste by 2025.

We have already achieved a huge reduction in the amount of household waste sent to landfill and no longer send any waste to landfill in the Scottish Borders. There has been an associated increase in the recycling rate and in the year to December 2020 over 56% of household waste was recycled.
