An application from Future Hawick requesting £4000 was received for the project Hawick Welcome 2023

DECISION NOTED that:

It was agreed to recommend that Teviot & Liddesdale Area Partnership award a grant of £863.00 towards this project and this total is derived from – (a) £643.00 for host uniform purchases and alterations and (b) £220.00 for brochure distribution costs. On this point it was noted that the amount paid is £0.40p per mile whereas it was felt by the Panel that a general fee paid by most organisations is more likely to be £0.25p per mile and therefore the costs for this element were reduced pro rata accordingly.

The Panel was very supportive of the work undertaken by the Welcome Host project and is acknowledged as an initiative recognised for the economic benefit it brings to the community.

The decision on the amount to be recommended was taken on the basis of the information provided in the application that the highest percentage of costs for the project are wages related to contractual posts and it was felt that this was not the best use of funding from the Teviot & Liddesdale Partnership.

Other comments made and noted were for example, in 2022 brochure delivery was stated as £90.00 whereas in the current application this has increased to £352.00 which is a significant increase.

The Panel was very supportive of the work undertaken by the Eskdale Pony Club and their initiative to hold a Games Rally to encourage new members

The decision on the amount to be recommended was taken on the basis of the information provided in the application that the Club is based between Langholm/Newcastleton/Teviothead/Hawick and whilst Langholm is not part of Scottish Borders Council and the associated Teviot & Liddesdale Area Partnership, then the other two name communities ie Newcastleton and Teviothead (part of Upper Teviotdale and Borthwick Water) do fall under the remit of the T&L Partnership, and it was therefore felt that a third share of the costs should be met by Hawick Community Council and that it would be the recommendation that the Club equally apply to the other two T&L Community Councils for the other respective shares
